Summary: Under the direction of the Camp Director, assist in the maintenance and repair of the camp's buildings, grounds, equipment and other facilities consistent with the mission and established policies and procedures of the camp. Also would perform most of the housekeeping duties and some of the kitchen and cook duties.

Key Job Responsibilities:

- Clean cabins, lodges, bathrooms, dining hall, kitchen, and the like according to health code standards (duties include sweeping, scrubbing, waxing floors, washing windows and screens, etc.)
- Replace and/or stock soap, toilet paper, paper towels, etc.
- Maintain camp grounds and area
- Empty trash cans and recycling cans
- Operate necessary grounds care equipment such as mower, tractor, chainsaw, etc., in a safe and efficient manner
- Be aware and make necessary changes to hazards found in camp
- Assist in the repair of buildings and facilities (make minor repairs as needed)
- Paints or stains building exteriors and interiors
- Maintains shop, maintenance yard, and equipment related to building maintenance and other related duties in safe and sanitary condition
- Ability to greet rental groups and assist them courteously when necessary
- Assists Maintenance Supervisor as agreed upon with projects where additional strength/support is needed
- Provides assistance for camp programs or kitchen/cook help if needed
- Performs all duties in accordance with prescribed regulatory compliance guidelines, including local, state and federal guidelines as well as American Camp Association accreditation standards
- Assist with emergencies on site
- Follow schedule for checking equipment for safety, cleanliness and good repair
- Responds to emergencies, accidents, fires, weather-related problems

Qualifications:

- A high school diploma or its equivalent or two years of experience in a facility and site maintenance, construction, or grounds keeping business.
- Current certification in first aid and CPR is desirable.
- Valid and current driving license.
- Cleared background check/drug screen

- Ability to work on a team, relate and work well with others.
- Self-starter and organizer.
- Ability to accept guidance, direction and supervision.
- Proficiency in the safe and proper use of power equipment and tools, heavy and light machinery, and building materials.
